FRIDAY UPDATE: 08.30.24

Scams

08.24 The victim reported she was contacted via FB messenger by a person ID'ing themselfe as Alex Aguilar claiming to be from Texas. They said they wanted to buy an item from his FB page. They agreed upon a price of \$100 plus fees and shipping for a total of \$135. The victim sent her Venmo link and Alex said he tried sending a payment and his payment to her was declined. He messaged her to send a refund transaction of \$100 from her Venmo account to his so he gets the correct link. She sent \$100 and Alex said it bounced back and told her to send it again. She did. Later, she realized \$200 was taken from her account and the link he gave her was not a correct Venmo account. She has not heard anything more from Alex and his FB account is gone.

08.24 The victim advised me that he had recently found a Galaxy S24 Ultra on Facebook market place for sale. He setup a meet with the person selling the phone at Sand Creek Elementary in Coon Rapids. He was met by a younger looking black juvenile around 14 years old. The victim looked at the phone and believed the phone to be legit and he paid the male \$500 for the phone. Once he returned home he started to notice things about the phone making him realize he bought a fake phone. The profile on Facebook he bought it from showed a name of Jasmine Smith with a photo of a white dog. He said that same profile has multiple phones that they still have up on the site.

08.26 The victim stated that on Saturday he received a phone call from the Clearinghouse Sweepstakes with a caller who identified himself as "Dr. Dave Sawyer". The caller stated that he had won \$10,000,000 and that he would need some information to receive it. He gave the caller his MN DL# and the name of his bank. The caller then asked him to open a new account, to which he refused. The deputy advised him to monitor his credit accounts.

08.28 The caller reported a suspicious phone call she received about her Medicare number. She stated that she had received four phone calls from two different numbers asking her for her Medicare number for a back brace upgrade. She stated that she already has a back brace and is not due for another one.

08.29 A father reported his daughter was a victim of a fraudulent scam. She was contacted by an unknown person claiming to be with the Wells Fargo Fraud Department. They told her that her account had been compromised and that she needed to withdraw her funds and deposit them into a different account at an ATM. She went to her bank and withdrew all the money from her account. She was provided a credit card account to enter into the ATM and she deposited \$6,100 to this account. There was a temporary PIN she had to use to put the money in that account.

08.29 A brother is reporting for his brother who is a low functioning adult. He said that he found out that his brother had attempted to deposit a \$5,000 check which never cleared. He said that his brother then put his own money on gift cards and sent them to a person via text message @ 316-

277-4802 and is now out \$50,000. He believes that his brother met these people in his online gaming world and that is how he got scammed.
